Market Opportunity

In 2023, over \$2.2 billion was lost due to crypto fraud and rug pulls (Source: Chainalysis). Current centralized anti-fraud systems fail to adequately address the security needs of the decentralized world.

Magic Mangoose fills this gap by offering a data-driven, permissionless solution capable of operating across multiple blockchains, responding to the growing demand for interoperable security.
